### License for Storage, State of Texas, County of Travis

This license agreement is made and entered into by and between Austin Yacht Club, being the "Licensor" and hereinafter also called "AYC," and the owner described above, whose address is listed above, and the vessel and equipment described above who are jointly referred to hereinafter as the "Licensee."

1. **General:** Upon assignment of a storage location by Licensor, Licensee is granted, the right to use that certain, storage space for the vessel and equipment described above, hereinafter referred to as the "Vessel." Storage licenses are monthly and self renewing for members who remain in good standing with AYC and abide by current AYC Harbor Rules, including slip usage policies. Licensee agrees to accept any future changes in rental rates or to remove the Vessel from AYC premises. License rates can be changed without notice by a vote of the AYC Board of Directors.

2. **No Specific Slip:** It is specifically agreed that this license covers the right to tie said Vessel at AYC, but does not grant the Licensee the right to any specific slip. AYC shall designate which slip is to be used by Licensee, and AYC may change the slip to be used at any time.

3. **Change in Ownership:** Notice must be given at the office of AYC, prior to removal of said Vessel from AYC premises. In the event that said Vessel changes ownership, AYC must be notified prior to the day of said change of ownership. Slip assignment does not convey to the new owner, and the new owner will be required to remove the Vessel from the former owner's assigned slip. The new owner can request a new slip assignment by following the AYC slip assignment process as documented in the AYC harbor rules.

**4. Storage Lien: LICENSEE AGREES THAT ALL CHARGES ACCRUING UNDER THE TERMS OF THIS CONTRACT SHALL GIVE LICENSOR AN EXPRESS LIEN UPON LICENSEE'S VESSEL AND LICENSEE HEREBY GRANTS TO LICENSOR A SECURITY INTEREST IN SAID VESSEL TO SECURE SAME. NO VESSEL SHALL BE REMOVED FROM AYC UNTIL ALL CHARGES ARE FULLY PAID. AYC IS GRANTED THE RIGHT TO SECURE SUCH VESSEL FROM REMOVAL UNTIL ALL CHARGES ARE PAID IN FULL. THE RIGHT TO SECURE THE VESSEL INCLUDES ITS REMOVAL FROM THE WATER. THIS SECURITY INTEREST INCLUDES ALL COSTS OF SECURING THE VESSEL.** \_\_\_\_\_ **Initials of Licensee.**

AYC reserves the right to remove and hold said Vessel until all delinquent charges have been paid in full. The Licensee agrees that should the above conditions arise, that AYC will in no way be held liable or responsible for any loss, damage or deterioration of or to said Vessel or Licensee due to said removal and/or storage. The Licensee also agrees to be liable for all costs incurred by AYC in the removal and/or storage of said Vessel. The Licensee understands that AYC may be required to give notice to any lien holder with an interest in the Vessel, of the delinquency and breach of this agreement, within 10 days of Licensee's delinquency/breach in order to protect AYC's Lien interests. Licensee grants AYC permission to do so as may be required to protect AYC's lien interests.
